The **WAC certification** is designed to fit every structure with the status of employer (company, local/public authorities, public services and establishments, associations, etc.). A "structure" is understood either as a whole (a big business) or as a service, a managerial team, a subsidiary of a bigger organisation.

The project aims at promoting and recognising companies and professional structures which successfully engage in the promotion of physical activity, employees' health and wellness through a certification scheme. It also aims at increasing organisations' willingness to engage in this path.

Interested companies can apply for the pioneers' phase by reading the specifics and **completing the following form together with an engagement letter** (2 A4 pages maximum specifying their motivation and criteria to be part of WAC pioneers, What your company already implement on a managerial level (policy, HR, organisation, resources, external collaboration...), What activities are implemented within your company for employees (physical activity and sport programmes...) their vision around physical activity and well-being in general at the workplace, a summary of activities implemented in this field....).

You can also send us all documents and appendixes which could further support your application. The application is will be reviewed and approved by an independent jury composed of different WAC partners.
